B. El Marie Conklin Small Loan File - El Marie Conklin

El Marie presented issues with Small Loans. May 2018 started paying on small loan. She wrote a check to pay off the remainder. August 22nd her and her son had \$2,500 taken out of their People's Fund check. Councilwoman Monica Mayer suggest the CEO investigate this issue, bring in CFO, Mary Ellen Sun and Andrea, figure it out. Another issue El Marie addressed was for June Yellow Lodge, who borrowed \$4,250. She has paid \$5,675 and \$2,855.44 interest still owed. Councilwoman Monica Mayer suggests bring to Executive Committee to request loan forgiveness. \$835.00 in old checks from South Dakota. June was picked up in July for her ex-husbands bounced checks, her name is on the checking account also. Request to pay off \$835.00. North Segment will assist with the \$835.

Report submitted for the record. Current meetings include discussions regarding methods of repayment and collections on delinquent business loan accounts. Current training continues to includes learning how to navigate our new loan system Amazon Workspace. The TAT Business Loan program is currently working towards implementing a new loan ledger software that will meet the needs of the department. The TAT Business Loan program is working closely with our attorneys at circling eagle law to collect from our current list of delinquent clients. The current business loan officer is working to contact business loan clients whose loans are past due and determine a plan for the borrower to become current with his/her payments again. Update: As of September 2022, the business loan department has two perspective business loan applications. The application is currently being processed in the business loan department and will wait further action as the application is approved or denied. The business loan department successfully enforced resolution 00-175-DSB which obligates tribal employees to wage garnishments and allows the business loan department to withhold wages to pay back debt owed to the tribe. The business loan department has successfully collected \$688,970.99 in collections as of September 22nd, 2022.
