Emailed an update breakout of companies/operators. Joe Bram Hall of Inspection Enforcement is coordinating with Kenny Lyson and has a meeting in New Town. Joe Bram Hall and a couple SPET's and Greg Morral, Supervisory NRS will be in attendance to go over FY24 Priorities & FY 23 Findings. FY24 have completed strategy for inspections. NDRMP BLM is finishing up responses comment to the draft RMP and development of the Draft Alternative. NDFO reached out to the Operators last Friday and is planning our next Cooperator Meeting for the week of November 27th & December 4th. The NDFO will also be reaching out to the Tribe to set up time to discuss the RMP. This came up at the last FBR Partners meeting. Provided to the link to E-Planning to review the RMP. Received one CA MDM102683 for Devon WPX last week from the B.I.A. The BLM coded and issued a first production memo last as well. This CA has had a producing well since 2013, and in 2020 there are 7 additional wells drilled. Kelly & Chase. Pending with the BIA now. This meeting will give MHA Nation Energy Department to mention any concerns that they may have. On October 17, 2023, BLM did send out notices for the lease sale in December 2023. The parcels in this lease sale are in the Van Hook Arm. BLM did pull the lease sale ND2023126869. That is the parcel involved in a trespass. (Slawson) It will not be offered in the sale. MM asked to be updated on that parcel because it is in North Segment.
