VI. SPECIAL GUESTS & ELDERS:

A. Elders Museum Board – Ramona Pond

Submitted a previously budget which was approved before at \$5,700,000 that included a tribal match. Ramona Pond provided a brief history of the project that was kicking off just before the Covid epidemic. They had brought on an archetech & contractor (Donmore out off Minesota). Proposals date of May 27th. Project Manager has been advertised. Chairman Mark N. Fox noted that it is critical to get updated plans & numbers & a Project Manager. The Archetech needs to update their numbers. After the Covid epidemic andd the supply chain issues nation wide the construction has tripled and recommended competitive bids and asked that what ever is built that it works with the development plan of the pennisula as a destination resort. Chairman Mark N. Fox recommended that they review their plans with the Interpretive Center in mind. Ramona noted that they have \$5 million in their fund with no other sources. Chairman Mark N. Fox explained that once we have an updated cost we can move forward on the Tribe's side. Chairman Mark N. Fox recommended trying to get the ground work in before the ground freezes.
