The medical bills were not paid for that accident. The bills were sent to collections. DCI Credit took Ms. Lizor's savings out of the bank and also her daughters' own savings. Ms. Lizor asked the committee how she could recoup some of her savings. The amount they took was \$4,753.32. Pam Lewis advised that there isn't much that can be done because the tribe is not associated with Boon Insurance any more. Councilwoman Monica Mayer stated that to help Ms. Lizor they could help her from each segment. Councilman Fred Fox stated that he is fine with each segment helping. Councilwoman Monica Mayer stated that North Segment will start the paperwork for getting help from the Segments.

6) Proposal for Payment of Employee Coinsurance

MHA Nation Employee Deductible for Treatment Services Policy. The Good Road Recovery Center (GRRC) will provide a deductible waiver of 30% of substance use disorder (SUD) treatment services or not to exceed \$3,000 for authorized individuals under the MHA Nation Employee Plan for approved contracted SUD facilities for individuals placed by the MHA Recovery Team. Must work at least 30 hours per week for MHA tribal affiliate or program and enrolled in the MHA Nation program. Must be an enrolled member of the Three Affiliated Tribes (TAT). If you are the policy holder seeking deductible coverage for legal spouse, children under the age of 26, or children past the age of 26 who are fully dependent on you for support due to a mental or physical disability (and are indicated as such on your federal tax return) covered under your policy, they MUST be an enrolled member of TAT. Additionally, client placement MUST be authorized by the MHA Recovery Team to an approved contracted facility with MHA Nation. Eligible individuals are required to contact the MHA Recovery Team at 701-421-8869 to apply for The GRRC coinsurance waiver. All applicants will be reviewed and approved by the MHA Intake Team to ensure TAT tribal enrollment and MHA insurance coverage eligibility. All prior authorizations will be approved and processed by the MHA Intake Team. Final consent is provided from the Utilization Management Specialist. The coinsurance waiver payment will be taken from GRRC fund code 0232. Your medical benefits end the last day of the month in which your employment ends.
