Fox stated that TBC approved a small loan for her husband Waldron Crows Breast not long ago. It was approved based on the probate money that would be coming in. Also, it was approved subject to the policy and procedures. Not long after that, the balance that Ms. Crows Breast said she had did not match the balance the the Small Loans Department had. Because there amount was significantly different, a hold was put on the small loan until it was all straigntened out. Ms. Sun stated that what they are going to do is not apply the accrued interest. Now Ms. Crows Breast will not owe and can receive the loan that TBC already approved. After Ms. Crows Breast recieves money in her probate she will be able to pay the loan off. An exception is being made for Ms. Crows Breast. No collateral or co-signor is needed.

VII. <u>CHAIRMAN'S REPORT</u> - Chairman Mark N. Fox.

Chairman Mark N. Fox gave an update to the TBC about the things he has been working on. One of the main topics was about oil and gas. Tomorrow, June 9th, 2023 will be the signing of the acquisition of the Enbridge pipeline. This will service the Thunder Butte area. When all the work is complete on this, the tribe will be making more money. Chairman Fox also mentioned that the MHA Nation will be involved in a Hydrogen Hub. It is a multi-billion-dollar project. Every ounce of the flaring will be used to create hydrogen. Hopefully, the MHA Nation will be the feed stock for one of the target markets which would be transportation. (Hauling/trucks) The MHA Nation is the strongest candidate to be able to fund this. There will only be 8 to10 nationwide. There is a good chance the MHA Nation will be one of the ten spots for the Hydrogen Hub. It would increase royalties for everyone if the MHA Nation builds this facility. The tribe will know within six months if they will be able to be a part of this Hydrogen Hub venture. He was not able to go to NCAI. Chairman Mark N. Fox stated that Gov. Burgum will be running for US President. He met with him in regards to tribal issues. Chairman Mark N. Fox expressed his condolences to those in mourning. The Summer



Kick-Off in Bismarck is coming up. There is about 1,000 tribal members in the Bismarck area. In June 21st-22nd, 2023 there will be a N.D. Gov't to Tribal Gov't Conference. Chairman Mark N. Fox stated that the TBC is helping to sponsor the 4th of July event in Minot. Weight Loss Contest Summer Slime Down Final day with over 100 participants.

WHEREAS, White Shield Segment and EMS solicited a Bid (copy provided hereto and made a part hereof by reference) from Premier Specialty Vehicles for a new ambulance equipped with all amenities necessary for providing the people of the Segment and the MHA Nation the highest quality emergency services possible, and respectfully ask that the Tribal Business Council of the Three Affiliated Tribes rescind the previously approved Resolution No. 22-265-FWF, and that it approve the purchase and authorization for payment for the Braun Liberty Type 1 Ambulance, as more particularly described in the accompanying Bid, from Premier Specialty Vehicles.

Chairman Mark N. Fox stated we need to get people into treatment regardless of what their motivations are. When people get to treatment their mind frame changes and their lives can change for the better. We cannot always worry about procedures. We need to help the people. Chief Judge Christianson stated that he feels our judicial system goes above and beyond to get people into treatment. He feels he may be misinformed. Chairman Mark N. Fox also stated that he is an educated man and can read the complaints made to him.
