United Concordia Insurance covers \$3,000, there were 2 benefits \$5,899.41 and its responsibility is \$7,128.59. He has had extensive dental work done already but broke his jaw and needs more dental work. Tribal Health Insurance will investigate the issue.

A. Elbowoods Memorial Health Center (EMHC) - Dr. Kathy Eagle-Williams, CEO & Dr. Anita Martin, CMO

Contract ends Sept 5th, (Dentist) This will be for two days in Twin Buttes. This still needs to be sent to the Legal Department for review.

Motion: Councilman Fred Fox moved to forward Bridget Peters Contract to Executive Committee. Councilwoman Sherry Turner-Lone Fight seconded the motion. Vote: 3-0-0. Motion carried.

2) Federal Grant Management Training

2-day training for federal management of grants. Will send 10 or 14 staff. The cost is over \$10,000.

Motion: Councilman Fred Fox moved to forward request for \$10,000, fees for training to Executive Committee. Councilwoman Sherry Turner-Lone Fight seconded the motion. Vote: 3-0-0. Motion carried.

3) Quarterly General Staff Meetings

Requesting permission to conduct general staff meetings quarterly, want to set a regular date to meet quarterly. Would need to close the clinic for this training. The next one will be Nov, Feb, May, and Aug. It's an annual training course, it's a requirement. Could the clinic be open for emergencies only? Jared Eagle states, maybe we can work this out by doing double sessions, one in the morning and one in the afternoon.

4) Shredder Purchase

EMHC to order industrial shredders the cost will be over \$10,000. The committee suggest ordering the shredders.

Motion: Councilman Fred Fox moved to forward EMHC Shredder Purchase to Executive Committee. Councilwoman Sherry Turner-Lone Fight seconded the motion. Vote: 3-0-0. Motion carried.

Reported that EMHC will be conducting STD screening at the pow wows for syphilis. Also noted that there is a shortage of penicillin right now and they are having trouble

Dr. Froelich states they are working on getting some of the contracts to FTE's so they can get benefits. Councilwoman Monica Mayer suggest looking at all the contracts. Will wait on moving forward until Dr. Froelich can bring more information into the next meeting.

3) Pod Cast - POC's.

Requesting permission to start a Pod Cast. MHA Nation information will not be mentioned. They will be starting out small. Have reached out to the radio station here and looked at the equipment. The podcast will be education based. Want to bring in people with different careers.
