### 1) TATLE Explorer's Program MOU

TATLE Explorer's Program MOU with Boy Scouts of America and Explores. Would like to educate in the schools and develop future recruits. Mr. Thomas Huether gave a description of the Explorer program, hands-on training. LE has spoken with area Superintendents and they are in favor of it. There are many rewards for those that participate in this, and it would be good for the communities. It is like the ROTC Program. The program is already in five communities in the state of ND. If MHA Nation approves of this program, they will be the first Native American community to do so. Mr. Phil Packineau stated to do this they will need to add additional funding into Law Enforcement's budget to cover the Police Explorers Program. Councilwoman Monica Mayer recommended that Administrator Phil Packineau write this into his budget for the 24 Fiscal Yr.

Motion: Councilman Fred Fox moved to forward Boy Scotts of America and Police Exploring MOU budget to Executive Committee with budget. Councilwoman Sherry Turner-Lone Fight seconded the motion. Vote: 3-0-0. Motion carried.

Councilwoman Monica Mayer advised the committee and LE of a situation that occurred at her home. The suspect was arrested.

Officer Roy mentioned the duties of a *Community Service Officer*. Their duties are limited. A position of this nature may be beneficial to the MHA Nation within the Segments. Councilwoman Monica Mayer advised Chief Nelson Heart Jr. to write up a proposal for this position.

#### **H.** Adult Detention – Evan Beemer, Administrator

Report submitted for the record. Thus far for the month of June the Gerald "Tex" Fox Justice Center (GTFJC) currently has 15 Correctional Officers on staff with 6 Positions open, 8 Corrections Officers are currently IPA uncertified. From 6/01/2023 to 6/30/2023 at 0800 hours there were 113 inmates brought into the custody of the GTFJC. Our capacity is currently 36 inmates. 65 were Males and 48 were Females. 45 were arrested in New Town, 24 in Four Bears, 22 in Parshall, 12 in Mandaree, 9 in White Shield and 1 in Twin Buttes. 82 were under the influence of Drugs and/or alcohol. There were 257 charges assigned to the 239 inmates creating an average of 2.12 charges per person. We had 5 transports for the month of June. We had 9 Facility Incident Reports and 29 Serious Incident Report for the month of June.

#### 1) Summit Food Service

Resolution presented. Program would like to implement, food service. The current cook has attendance issues due to health reasons. The program can offer a wellbalanced diet. Cost and time savings, working on this now. \$273,000 in food cost. \$226,000 per year is what it should cost. Summit Foods will provide workers. Contract will assist the cook. The budget for the JTFJC is \$3.4 million dollars. They split that between the Adult and Juvenile services.

Motion: Councilman Fred Fox moved to forward Summit Food Service Contract for meal services at the Justice Center to Executive Committee subject to Legal review. Councilwoman Sherry Turner-Lone Fight seconded the motion. Vote: 3-0-0. Motion carried.

#### 2) Pay Scale Matrix

Compensation, Evan states he was a police officer and had a low morale in a low position. Now the Justice Center is not in good shape when Evan started to work there. Their rate if pay is less that the rate of the local area. Have 2 lieutenants and 2 Sergeants, and 1, and 4 CO's. Looking at 1.5 for budget in 2024 from the federal side. 1.5 overall and the total need will be brought back to TBC.

**Motion:** Councilman Fred Fox moved to forward Pay Scale Matrix to Executive Committee. Councilwoman Sherry Turner-Lone Fight seconded the motion. Vote: 3-0-0. Motion carried.



### 3) Vape Pen Usage

The Fort Berthold District Court and the Juvenile Department, as part of their duties and responsibilities to protect and provide services to our MHA youth in elementary, and high schools on Fort Berthold reservation, and The Fort Berthold District Court and the Juvenile Department continue to see more juveniles using vape pens, and The Fort Berthold District Court Juvenile Department has documented some of the vape pens have TCH and other illegal substances in the pens. The Fort Berthold District Court, in coordination with the Juvenile Department, requests vape pens be prohibited on the Fort Berthold reservation, in all segments in all schools. Presented resolution entitled "Vape pen use on Fort Berthold Reservation."

CIS is a relational database management system primarily built on Microsoft technology for the sole purpose of tracking information related to Tribal Child Support Enforcement (TCSE). CIS is an event driven application that relies on TCSE staff interaction and is classified as office automation. CIS utilizes Microsoft's SQL Server Express and the Microsoft Office Suite which includes Access, Excel, Outlook, and Word as part of its general function.

*Motion:* Councilman Fred Fox moved to forward with recommendation of approval the Service Contract with Access and Data Solutions, LLC to TBC. Councilwoman Sherry Turner-Lone Fight seconded the motion. Vote: 3-0-0. Motion carried.
