A clerk salary matrix and organizational chart has been completed and approved by the Judicial Committee and TBC, we are waiting for final disbursement of these increases. The clerks are very happy to see the upgrades and are thankful to those who made this possible! There have been regular meetings regarding evaluation and self-improvement to justify any promotions for staff. The administration has been conducting meetings with supervisors to put a process for promotion in place. The Justice Commission is planning on having a meeting in March (possibly the 15th), the Justice Commission is now meeting quarterly. The Court has completed an interview and the other background component to complete the process for selection of a new Judge, the consultant contract is attached.
