



**RESOLUTION OF THE GOVERNING BODY
OF THE THREE AFFILIATED TRIBES
OF THE FORT BERTHOLD INDIAN RESERVATION**

A Resolution entitled, “*Tribal Business Council Approval of Application for the Rehabilitation Services Administration, American Indian Vocational Rehabilitation Services CFDA Number 84.250N.*”

WHEREAS, This Nation having accepted the Indian Reorganization Act of June 18, 1934, and the authority under said Act and having adopted a Constitution and By-laws under said Act; and

WHEREAS, Pursuant to Article III, Section 1 of the Constitution and By Laws of the Three Affiliated Tribes (or “Tribes”), the Tribal Business Council is the governing body of the Tribes; and

WHEREAS, The Constitution of the Three Affiliated Tribes authorizes and empowers the Tribal Business Council to engage in activities on behalf of and in the interest of the welfare and benefit of the Tribes and of the enrolled members thereof; and

WHEREAS, Pursuant to Article VI, Section 5 (1) of said Constitution, the Tribal Business Council has the power to adopt resolutions regulating the procedures of the Tribal Business Council and other Tribal agencies and Tribal Officials on the Reservation; and

WHEREAS, Under the U.S. Department of Education New Rehabilitation Services Administration (or “RSA”) Funding Opportunities, the Three Affiliated Tribes is eligible to apply for funds for Fiscal Year 2021 under “Vocational Rehabilitation Service Projects for American Indians with Disabilities,” CFDA Number 84.250N. The Tribes’ Vocational Rehabilitation Program is authorized by Section 121 of the Rehabilitation Act of 1973, as amended, and implemented by the program regulations at 34 CFR Parts 369 and 371; and

WHEREAS, The Tribal Business Council has determined that authorizing the Tribes’ Planning and Grants Department and Vocational Rehabilitation Program staff to submit an application for the aforementioned Grant from the U.S. Department of Education Rehabilitation Services to Native American Indians residing on or near the Fort Berthold Indian Reservation, in accordance with the 1998 Amendments for the Designated Trial Unit 121 of the Rehabilitation Act, is in the best interests of the Tribes and the enrolled members thereof.

NOW, THEREFORE, BE IT BE RESOLVED that the Tribal Business Council of the Three Affiliated Tribes authorizes the Tribes’ Planning and Grants Department and Vocational Rehabilitation Program to submit application for the aforementioned Notice of Funding Opportunity “Vocational Rehabilitation Service Projects for American Indians with Disabilities,” CFDA Number 84.250N; and

BE IT FURTHER RESOLVED that the Tribal Business Council makes the commitment of 10% per year of the total Grant funds in monetary and/or in kind contributions as provided in the Grant application; and

BE IT FINALLY RESOLVED that the Tribal Business Council hereby authorizes Tribal Chairman Mark N. Fox and Tribal Secretary Fred W. Fox to sign and certify all agreements, applications, and other documents necessary for said Grant application.
