

# RESOLUTION OF THE GOVERNING BODY OF THE THREE AFFILIATED TRIBES OF THE FORT BERTHOLD INDIAN RESERVATION

A Resolution Entitled: "Approval of Home Site Leases and Utility Corridors for Home Sites – April, 2021."

- WHEREAS, This Nation having accepted the Indian Reorganization Act of June 18, 1934, and the authority under said Act and having adopted a Constitution and By-Laws pursuant to said Act; and
- WHEREAS, The Constitution of the Three Affiliated Tribes (or "Tribes") generally authorizes and empowers the Tribal Business Council to engage in activities on behalf of and in the interest of the welfare and benefit of the Tribes and of the enrolled members thereof; and
- WHEREAS, Article III of the Constitution of the Three Affiliated Tribes provides that the Tribal Business Council is the governing body of the Tribes; and
- WHEREAS, Article VI, Section 5 (l) of the Constitution of the Three Affiliated Tribes provides that the Tribal Business Council has the power to adopt resolutions regulating the procedure of the Tribal Business Council and other Tribal agencies; and
- WHEREAS, The Three Affiliated Tribes has authority to approve of Home Sites and Utility Corridors on Tribal land; and
- WHEREAS, The Three Affiliated Tribes finds it beneficial to provide for use of Tribal lands for Home Site Leases and Utility Corridor Easements.
- NOW, THEREFORE, BE IT RESOLVED that the Tribal Business Council of the Three Affiliated Tribes approves the Home Sites and Utility Corridors listed below:

### **North Segment - Home Sites:**

• Elizabeth Tikanye, a TAT Enrolled Member, for a 2.5-acre home site, Lot 15, Block 1, Little Shell Creek Subdivision on T394A-F, Section 2, T. 150 N., R. 92 W., Mountrail County, 5<sup>th</sup> PM of ND, containing an 100% Tribal interest, more or less.

#### Four Bears Segment - Home Sites:

 Clairesse and Nathan White Horse, a TAT Enrolled Member, for a home site, Thunder Butte Subdivision on Allotment 301-T531A-B, Section 29, T. 152 N., R. 94 W., McKenzie County, 5<sup>th</sup> PM of ND, containing an 100% Tribal, more or less.

#### West Segment - Home Sites:

 Leigh Arlis Brown Eyes, a TAT Enrolled Member, for a home site, Allotment 301-T710A, Section 2, T. 149 N., R. 94 W., McKenzie County, 5<sup>th</sup> PM of ND, containing an 100% Tribal, more or less.



 Michaela Ann Bacon, a TAT Enrolled Member, for a home site, Allotment 301-T710A, Section 2, T. 149 N., R. 94 W., McKenzie County, 5<sup>th</sup> PM of ND, containing an 100% Tribal, more or less.

## **Utility Corridor:**

- 1. All right-of-ways for utility corridor outside of the home site shall be obtained by the Home Site Applicant. This Resolution only covers Tribally-owned land for said corridor.
- 2. Approve an easement for the local electric cooperative, which will be providing an Electrical Service Line in the above-mentioned Tribally owned land in each segment. The easement will run a service line to a home site being built in and across all Tribal owned lands.
- 3. Approve an easement for Telephone/Internet service with the Telephone Cooperative for providing a Service Line in the above-mentioned Tribally owned land in each segment, in and across all Tribal owned lands.
- 4. Approve an easement for an access road with the Roads Department, to provide an access road in the above-mentioned Tribally owned land in each segment. The easement will run a road to the home site being built in and across all Tribal owned lands;
- 5. Approve an easement from the meter pit to the home for a Water Service Line with the homeowner in the above-mentioned Tribally owned land in and across all Tribal owned lands.
  - a. The portion of the Water Service Line from the meter pit to the homeowner's house will be the homeowner's responsibility to operate and maintain.
  - b. In accordance with 25 CFR § 169, Subpart B Service Line Agreements, the homeowner agrees to sign a service line agreement with Fort Berthold Rural Water.
  - c. The homeowner agrees to comply with the terms of the latest version of the Fort Berthold Rural Water Supply System Policy and Procedures for Water Service, including signing a water service agreement with FBRW.

**BE IT FINALLY RESOLVED**, that the Chairman is hereby authorized to execute such documents and take such further actions as are necessary to carry out the terms and intent of this Resolution.



#### CERTIFICATION
