



**RESOLUTION OF THE GOVERNING BODY
OF THE
THREE AFFILIATED TRIBES
OF THE
FORT BERTHOLD INDIAN RESERVATION**

A Resolution Entitled "Approval of the Relinquishment of Inola Denae Lowery Enrollment from Membership in the Three Affiliated Tribes."

WHEREAS, This Nation having accepted the Indian Reorganization Act of June 18, 1934, and the authority under said Act and having adopted a Constitution and By-laws pursuant to said Act; and

WHEREAS, Article III of the Constitution of the Three Affiliated Tribes provides that the Tribal Business Council is the governing body of the Tribes; and

WHEREAS, The Constitution of the Three Affiliated Tribes authorizes and empowers the Tribal Business Council to engage in activities on behalf of and in the interest of the welfare and benefit of the Tribes and of the enrolled members thereof; and

WHEREAS, The Constitution and By-Laws of the Three Affiliated Tribes empowers the Tribal Business Council to revise the membership rolls and to govern future membership rolls; and

WHEREAS, Inola Denae Lowery, whose Enrollment Number was presented to the Tribal Business Council at this August 12, 2021 meeting and who is an adult aged 18 years or older, has voluntarily submitted a relinquishment request to relinquish his/her membership from the Three Affiliated Tribes, in writing and notarized.

NOW, THEREFORE, BE IT RESOLVED, by the Tribal Business Council of the Three Affiliated Tribes that above-referenced Inola Denae Lowery is hereby relinquished from the official membership roll of the Three Affiliated Tribes; and

BE IT FINALLY RESOLVED, that the above-referenced Inola Denae Lowery shall be removed from the official membership roll of the Three Affiliated Tribes upon the approval of this Resolution.
