



**RESOLUTION OF THE GOVERNING BODY OF THE  
THREE AFFILIATED TRIBES OF THE  
FORT BERTHOLD INDIAN RESERVATION**

***A Resolution Entitled: "Land Purchase – Allotment 301-2143 (Lindgren)."***

**WHEREAS,** The Mandan Hidatsa and Arikara Nation, also known as the Three Affiliated Tribes ("MHA Nation" or "Tribe"), having accepted the Indian Reorganization Act of June 18, 1934, the authority under said Act, and having adopted a Constitution and By-laws (the "Constitution") under said Act, and

**WHEREAS,** Pursuant to Article III, Section 1 of the Constitution, the Tribal Business Council is the governing body of the MHA Nation; and

**WHEREAS,** The Constitution authorizes and empowers the Tribal Business Council to engage in activities on behalf of and in the interest of the welfare and benefit of the MHA Nation and of the enrolled members thereof; and

**WHEREAS,** Pursuant to Article VI, Section 5(1) of the Constitution, the Tribal Business Council has the power to adopt Resolutions regulating the procedures of the Tribal Business Council, its agencies, and officials; and

**WHEREAS,** Article IX, Section 6 of the Constitution provides that the Tribal Business Council has the authority to acquire land by purchase; and

**WHEREAS,** The Three Affiliated Tribes has determined that it is in the best interests of the Tribe to acquire land; and

**WHEREAS,** The Tribe, by Executive Action, has approved the purchase of land described below; and

**WHEREAS,** The Tribal Business Council has considered the location of the below-described land, the potential public and economically beneficial use of the land, Tribal self-determination, and the negotiated purchase price; and

**WHEREAS,** After such consideration the Tribal Business Council approves the purchase of said land.

**NOW, THEREFORE, BE IT RESOLVED,** that the Tribal Business Council of the Three Affiliated Tribes hereby approves the purchase of the surface described below from:

**Samantha Lindgren**

For cash consideration of \$15,555.56, which is the negotiated value, utilizing funds from the FY2021 Budget.



**Allotment 301-2143, W½, Section 36, Township 147 North, Range 92 West, Dunn County, 5<sup>th</sup> PM of North Dakota, containing an undivided .027777778 interest, of a 320-acre tract, more or less, negotiated value of \$15,555.56.**

**Surface Only**

**BE IT FINALLY RESOLVED**, that the Chairman is hereby authorized to execute such documents and take such further actions as are necessary to carry out the terms and intent of this Resolution.


**CERTIFICATION**


