



**RESOLUTION OF THE GOVERNING BODY
OF THE
THREE AFFILIATED TRIBES
OF THE
FORT BERTHOLD INDIAN RESERVATION**

A Resolution Entitled: "Reserving Tribal Land for the Sahnish Development Authority."

WHEREAS, This Nation having accepted the Indian Reorganization Act of June 18, 1934, and the authority under said Act and having adopted a Constitution and By-Laws pursuant to said Act; and

WHEREAS, The Constitution of the Three Affiliated Tribes, also known as the Mandan, Hidatsa, and Arikara Nation (or "Tribes"), generally authorizes and empowers the Tribal Business Council to engage in activities on behalf of and in the interest of the welfare and benefit of the Tribes and of the enrolled members thereof; and

WHEREAS, Article III of the Constitution of the Three Affiliated Tribes provides that the Tribal Business Council is the governing body of the Tribes; and

WHEREAS, Article IV, Section 5(1) of the Constitution of the Three Affiliated Tribes provides that the Tribal Business Council has authority to adopt resolutions regulating the procedure of the Tribal Council and other Tribal Agencies and Tribal Officials of the Reservation; and

WHEREAS, The Tribal Business Council designates the below described Tribal Allotments 301-T 1510-A and 301-T 1510-C to be used by the White Shield Community, East Segment, for Community Development and Cultural Uses; and

WHEREAS, The Tribal Business Council finds it appropriate to authorize the use of the Tribal Land described herein, and to waive payment in consideration of the public benefit the granting of this designation provides.

NOW, THEREFORE, BE IT RESOLVED, that the Tribal Business Council of the Three Affiliated Tribes, hereby designates the following said allotments to be used by the Sahnish Development Authority within the East Segment for Community Development and Cultural Uses:

1. Sahnish Development Authority of the White Shield Community:
 - a. Tribal Allotment 301-T 1510-A, SE $\frac{1}{4}$ SW $\frac{1}{4}$, Section 13, T. 148 N., R. 88 W., McLean County, 5th PM of North Dakota, with a 100% Tribal Interest, containing 40 acres, more or less: and



b. Tribal Allotment 301-T 1510-C, E $\frac{1}{2}$ SW $\frac{1}{4}$ SW $\frac{1}{4}$ SW $\frac{1}{4}$, N $\frac{1}{2}$ SW $\frac{1}{4}$ SW $\frac{1}{4}$, SE $\frac{1}{4}$ SW $\frac{1}{4}$ SW $\frac{1}{4}$, Section 13, T. 148 N., R. 88 W., McLean County, 5th PM of North Dakota, with a 100% Tribal Interest, containing 35 acres, more or less.

BE IT FURTHER RESOLVED, that the Chairman is hereby authorized to execute such documents and take such further actions as are necessary to carry out the terms and intent of this Resolutions.


CERTIFICATION


