

## RESOLUTION OF THE GOVERNING BODY OF THE THREE AFFILIATED TRIBES OF THE FORT BERTHOLD INDIAN RESERVATION

## A Resolution Entitled "Approval of Voluntary Relinquishment of Fawnna Nicole Lee from Membership of the Three Affiliated Tribes."

- WHEREAS, This Nation having accepted the Indian Reorganization Act of June 18, 1934, and the authority under said Act and having adopted a Constitution and By-laws pursuant to said Act; and
- WHEREAS, Article III of the Constitution of the Three Affiliated Tribes provides that the Tribal Business Council is the governing body of the Tribes; and
- **WHEREAS,** The Constitution of the Three Affiliated Tribes authorizes and empowers the Tribal Business Council to engage in activities on behalf of and in the interest of the welfare and benefit of the Tribes and of the enrolled members thereof; and
- **WHEREAS,** The Constitution and By-Laws of the Three Affiliated Tribes empowers the Tribal Business Council to revise the membership rolls and to govern future membership rolls; and
- WHEREAS, Fawnna Nicole Lee, an adult whose Enrollment Number was presented to the Tribal Business Council at this June 27, 2022 meeting, submitted a notarized request to the Office of Tribal Enrollment to voluntarily relinquish her membership from the Three Affiliated Tribes.
- **NOW, THEREFORE, BE IT RESOLVED,** by the Tribal Business Council of the Three Affiliated Tribes that the above-referenced Fawnna Nicole Lee is hereby relinquished from the official membership roll of the Three Affiliated Tribes; and
- **BE IT FINALLY RESOLVED** that the above-referenced Fawnna Nicole Lee be removed from the official membership roll of the Three Affiliated Tribes upon the approval of this Resolution.
