



**RESOLUTION OF THE GOVERNING BODY OF THE  
THREE AFFILIATED TRIBES OF THE  
FORT BERTHOLD INDIAN RESERVATION**

**A Resolution Entitled, “*Approval of Funding for a New Four Bears Segment Apartment Complex in the Amount of \$10,000,000.00.*”**

**WHEREAS,** The Mandan Hidatsa and Arikara Nation (MHA Nation), also known as the Three Affiliated Tribes, having accepted the Indian Reorganization Act of June 18, 1934, the authority under said Act, and having adopted a Constitution and By-laws (the Constitution) under said Act, and

**WHEREAS,** Pursuant to Article III, Section 1 of the Constitution, the Tribal Business Council is the governing body of the MHA Nation; and

**WHEREAS,** The Constitution authorizes and empowers the Tribal Business Council to engage in activities on behalf of and in the interest of the welfare and benefit of the MHA Nation and of the enrolled members thereof; and

**WHEREAS,** The Tribal Business Council of the Three Affiliated Tribes has the authority to approve appropriations and budgets by resolution for housing development within the Four Bears Segment which includes the necessary infrastructure for scatter home development and subdivision development; and

**WHEREAS,** There is a great need for new housing for families in the Four Bears Segment; and

**WHEREAS,** A new apartment complex will be constructed in the Four Bears Segment to begin addressing the needs of the growing demand for housing.

**NOW THEREFORE BE IT FURTHER RESOLVED,** That the Tribal Business Council of the Three Affiliated Tribes appropriates the amount of \$10,000,000.00 for the Four Bears Segment Apartment Complex.

**BE IT FURTHER RESOLVED,** That the Four Bears Segment Apartment Complex budget request is hereby incorporated into the Three Affiliated Tribes General Fund Budget in the amount of \$10,000,000.00.

**BE IT FURTHER RESOLVED,** That the Chairman is authorized, after legal review, to sign necessary lease documents, contracts and agreements on behalf of the Three Affiliated Tribes for the above-described project, provided the cost of the project does not exceed \$10,000,000.00.
