

## RESOLUTION OF THE GOVERNING BODY OF THE THREE AFFILIATED TRIBES OF THE FORT BERTHOLD INDIAN RESERVATION

## A Resolution Entitled: "North Dakota Infrastructure LLC Land Property Purchase – South Segment."

WHEREAS,	The Mandan Hidatsa and Arikara Nation, also known as the Three Affiliated Tribes
ALL DO LO	("MHA Nation" or "Tribes"), having accepted the Indian Reorganization Act of
Fax 38	June 18, 1934, the authority under said Act, and having adopted a Constitution and
20 19	By-laws (the Constitution) under said Act, and

- WHEREAS, Pursuant to Article III, Section 1 of the Constitution, the Tribal Business Council is the governing body of the MHA Nation; and
- WHEREAS, The Constitution authorizes and empowers the Tribal Business Council to engage in activities on behalf of and in the interest of the welfare and benefit of the MHA Nation and of the enrolled members thereof; and
- WHEREAS, Pursuant to Article VI, Section 5(1) of the Constitution, the Tribal Business Council has the power to adopt Resolutions regulating the procedures of the Tribal Business Council, its agencies and officials; and
- WHEREAS, The MHA Nation has determined that it is in the best interest of the Tribes to acquire land; and
- WHEREAS, The Tribal Business Council through EA 2022-18 has considered the purchase of land legally described as:

Dunn County, North Dakota.

WHEREAS, The Seller of the above-described land is North Dakota Infrastructure LLC; and

- WHEREAS, The Tribal Business Council has considered the location of the above-described land, the potential public and economic beneficial uses of the land, Tribal self-determination, and the purchase price.
- NOW, THEREFORE, BE IT RESOLVED, that the MHA Nation's Tribal Business Council hereby ratifies EA 2022-18 and authorizes and approves the purchase of the above-described land from North Dakota Infrastructure LLC for the purchase price of One Hundred Twenty Thousand Dollars and Zero Cents (\$120,000.00), which is the negotiated price; and
- BE IT FURTHER RESOLVED, that the Tribes may make a formal request in the future that the land be taken into trust; and

**BE IT FINALLY RESOLVED**, that the Chairman is hereby authorized to execute such documents, pending legal review, and take such further actions as are necessary to carry out the terms and intent of this Resolution.

## CERTIFICATION
