

RESOLUTION OF THE GOVERNING BODY OF THE THREE AFFILIATED TRIBES OF THE FORT BERTHOLD INDIAN RESERVATION

A Resolution Entitled: "Acceptance of AIA A-133 Exhibit B, Amendment 2 GMP for Bid Pack 2, presented by CMAR McGough Construction for the Emergency Operations Center and Fire Management Building. Cost of Bid Pack 2 \$16,524,203.00."

- WHEREAS, This Nation having accepted the Indian Reorganization Act of June 18, 1934, and the authority under said Act and having adopted a Constitution and By-Laws pursuant to said Act; and
- WHEREAS, The Constitution of the Three Affiliated Tribes, also known as the Mandan, Hidatsa, and Arikara Nation ("Tribes" or "MHA Nation") generally authorizes and empowers the Tribal Business Council to engage in activities on behalf of and in the interest of the welfare and benefit of the Tribes and of the enrolled members thereof; and
- WHEREAS, Article III of the Constitution of the Three Affiliated Tribes provides that the Tribal Business Council is the governing body of the Tribes; and
- WHEREAS, Article VI, Section 5(1) of the Constitution of the Three Affiliated Tribes provides the Tribal Business Council authority to adopt resolutions regulating the procedure of the Tribal Council and other Tribal Agencies and Tribal Officials of the Reservation; and
- WHEREAS, The Tribes seek to protect the Tribes' interests when there is a disaster, pandemic, or other emergency declaration that affects the lives and livelihood of enrolled members and community members surrounding the Fort Berthold Indian Reservation; and
- WHEREAS, The Tribes seek to provide disaster mitigation, disaster recovery, education of first responders and the general public, improve communication systems with other agencies, provide a storm shelter and a safe room, logistical support for the Emergency Operations Centers staff to respond to emergency declarations, pandemic support and other emergencies as declared by the Tribal Business Council; and
- WHEREAS, The Tribes seek to maintain their wildland fire program, the Three Affiliated Tribes Fire Management Program, with a new and updated facility to conduct wildland fire mitigation and suppression activities for the Fort Berthold Indian Reservation and surrounding communities; and



- WHEREAS, The Tribal Business Council has approved McGough Construction co, LLC as the CMAR for the Emergency Operations Center and Fire Management building. There are 2 Bid Packs under this Contract for this project; and
- WHEREAS, A GMP of \$8,550,306.00, was previously submitted and approved for Bid Pack 1; and
- WHEREAS, Notification of bids for Bid Pack 2 was made according to TERO and the Tribes' Construction Management Offices (CMO) rules and regulations. The bids for Bid Pack 2 were closed on August 2, 2022; and
- WHEREAS, As part of the CMAR McGough construction contract, a GMP Amendment must be signed and the Amendment will be called AIA A-133 Exhibit A. The total GMP will be the sum of the amounts for Bid Pack 1 and Bid Pack 2; and
- WHEREAS, Bid Pack 2 includes interior and exterior finishes, pre-cast panels, general carpentry, sheetrock and framing, windows and doors, MEPF (Mechanical, Electrical, Plumbing, and Fire Suppression) roofing, low voltage, caulking, joint sealants, and fire stopping, fencing, landscaping, and signage. The Tribal Business Council has been notified by McGough Construction that the GMP for Bid Pack 2 is \$16,524,203.00.
- NOW, THEREFORE, BE IT RESOLVED, that the Tribal Business Council of the Three Affiliated Tribes based upon the above hereby authorizes and approves the Bid Pack 2 GMP of \$16,524,203.00 for the construction of the Emergency Operations Center and Fire Management Building; and
- BE IT FINALLY RESOLVED, that the Tribal Chairman is hereby authorized to execute such documents and take such action as is necessary to carry out the terms and intent of this Resolution.
