



**RESOLUTION OF THE GOVERNING BODY OF THE
THREE AFFILIATED TRIBES OF THE
FORT BERTHOLD INDIAN RESERVATION**

A Resolution entitled, "Authorization for Continuation of Elder Services Funding from the Administration for Community Living/Administration on Aging Older Americans Act Title VI Nutrition, Supportive Service and Caregiver Grants (Part A/B and C)."

WHEREAS, This Nation having accepted the Indian Reorganization Act of June 18, 1934, and the authority under said Act and having adopted a Constitution and By-Laws pursuant to said Act; and

WHEREAS, The Constitution of the Three Affiliated Tribes (or "Tribes") generally authorizes and empowers the Tribal Business Council to engage in activities on behalf of and in the interest of the welfare and benefit of the Tribes and of the enrolled members thereof; and

WHEREAS, Article III of the Constitution of the Three Affiliated Tribes provides that the Tribal Business Council is the governing body of the Tribes; and

WHEREAS, The Tribal Business Council is empowered to act in the interests of the health, safety, and wellbeing of the Tribes and all its members, including individuals age 55 and older; and

WHEREAS, Services made available by the funding received from the Administration for Community Living/Administration on Aging Older American Act has proven to be beneficial to the Tribes' elders and their caregivers; and

WHEREAS, The Tribal Business Council has considered the matter and believes that funding received under the Administration for Community Living/Administration on Aging Older Americans Act would continue to be beneficial to the Tribes' elders and their caregivers.

NOW, THEREFORE, BE IT RESOLVED, that the Tribal Business Council of the Three Affiliated Tribes respectfully requests the continuation of funding under the Administration for Community Living/Administration on Aging Older Americans Act Title VI grants (Parts A/B and C) in the amount of \$200,000 each year for the grant period from April 1, 2023 to March 31, 2025; and

BE IT FURTHER RESOLVED, that the Tribal Business Council declares that the elder population meets the eligibility requirements required by the Administration for Community Living/Administration on Aging Older Americans Act, Title VI grant for Nutrition and Supportive Services (Parts A/B), Family Caregiver Program (Part C); and



BE IT FURTHER RESOLVED, that the Tribal Business Council assures that the compliance requirements as well as the rules and regulations associated with the Title VI Parts A/B and C of the Older Americans Act shall be met; and

BE IT FINALLY RESOLVED, that the Tribal Business Council hereby authorizes Tribal Chairman Mark Fox to execute all applications, forms and other documents necessary to apply for said grant.

CERTIFICATION
