

### RESOLUTION OF THE GOVERNING BODY OF THE THREE AFFILIATED TRIBES OF THE FORT BERTHOLD INDIAN RESERVATION

#### A Resolution entitled, "Approving Purchase Agreement With Pinecrest 40, LLC"

- WHEREAS, The Mandan Hidatsa and Arikara Nation (the "Nation"), also known as the Three Affiliated Tribes, having accepted the Indian Reorganization Act of June 18, 1934, the authority under said Act, and having adopted a Constitution and Bylaws (the "Constitution") under said Act, and
- WHEREAS, Pursuant to Article III, Section 1 of the Constitution, the Tribal Business Council is the governing body of the Tribes; and
- WHEREAS, Pursuant to Article VI, Section 5(1) of the Constitution, the Tribal Business Council has the power to adopt Resolutions regulating the procedures of the Tribal Council, its Agencies and Officials; and
- WHEREAS, Article IX, Sections 1 and 3 of the Constitution, provides that the Tribal Business Council has the authority to manage and lease or otherwise deal with tribal lands and resources; and
- WHEREAS, Article VI, Section 5(c) of the Constitution specifically authorizes and empowers the Tribal Business Council to administer funds within the exclusive control of the Nation and to make expenditures from available Tribal funds for public purposes for the Nation; and
- WHEREAS, The Tribe is interested in purchasing land for development both within and outside the Reservation; and
- WHEREAS, Pinecrest 40, LLC has offered to sell to the Tribe land located within Dickinson, North Dakota; and
- WHEREAS, The land for sale is legally described as:

# Pinecrest Addition to the City of Dickinson, Stark County, North Dakota <u>Block 5</u>

Lot 1 (16.37 acres), Lot 2 (1.39 acres), Lot 3 (1.68 acres), Lot 4 (1.58 acres), Lot 5 (1.58 acres), Lot 6 (1.70 acres), Lot 7 (1.24 acres), South 7.27 acre portion of Lot 8

### <u>Block 6</u>

Southeast 3.69 acre portion of Lot 1 All together 36.5 acres more or less



- WHEREAS, The land for sale represents an opportunity for development and the construction of housing; and
- WHEREAS, A purchase agreement has been proposed, attached as Exhibit A, and reviewed by legal counsel who finds it acceptable.
- **NOW THEREFORE BE IT RESOLVED**, that the Tribal Business Council approves the purchase of the aforementioned land and authorizes the Tribal Chairman to execute the proposed purchase agreement.
- **BE IT FINALLY RESOLVED**, the Tribal Chairman is hereby authorized to take such further action as are deemed necessary to carry out the terms and intent of this resolution;
