

## RESOLUTION OF THE GOVERNING BODY OF THE THREE AFFILIATED TRIBES OF THE FORT BERTHOLD INDIAN RESERVATION

## A Resolution entitled, "Consent to Approval of a Right-of-Way across Tribal land (706A-A, T 734A and 1932) for the Mandaree-Stevenson Pipelines Project Submitted by Targa Badlands LLC."

- WHEREAS, The Mandan Hidatsa and Arikara Nation (MHA Nation), also known as the Three Affiliated Tribes, having accepted the Indian Reorganization Act of June 18, 1934, the authority under said Act, and having adopted a Constitution and By-laws (the Constitution) under said Act, and
- WHEREAS, Pursuant to Article III, Section 1 of the Constitution, the Tribal Business Council is the governing body of the MHA Nation; and
- WHEREAS, The Constitution authorizes and empowers the Tribal Business Council to engage in activities on behalf of and in the interest of the welfare and benefit of the MHA Nation and of the enrolled members thereof; and
- WHEREAS, Pursuant to Article VI, Section 5(1) of the Constitution, the Tribal Business Council has the power to adopt Resolutions regulating the procedures of the Tribal Business Council, its agencies and officials; and
- WHEREAS, Article IX, Sections 1 and 3 of the Constitution, provides that the Tribal Business Council has the authority to manage and lease or otherwise deal with tribal lands and resources; and
- WHEREAS, Leases and Rights-of-Way ("ROWs") across Tribal Trust land require the consent of the Tribal Business Council pursuant to federal and Tribal Law; and
- WHEREAS, Applications for Rights-of-Way ("ROWs") on Tribal Land are subject to the requirements of tribal law, including Resolution No. 13-109-VJB (Establishing Standardized Minimum Rates for Oil and Gas Lease Bonus, Royalties and Road and Pipeline Easements), Resolution No. 14-071-VJB (MHA Nation Application for Rights-of-Way and Use of Right-of-Way), Resolution No. 14-089-VJB (MHA Nation Pipeline Right-of-Way Terms and Conditions), and Resolution No. 15-045-LKH (Establishing a Procedure for the Approval of Leases, Rights-of-Way, Setback Variances and Permissions to Survey on Tribal Land), Resolution No. 17-117-FWF (Approval of Fee Structure), and Resolution No. 18-212-FWF and 21-082-FWF (Amending Fee Structure); and



- WHEREAS, Targa Badlands LLC submitted a ROW application for the Multi-use ROW Corridor (Mandaree-Stevenson Pipelines) project for Right-of-Way Consent for a 45-footwide easement consisting of a 15-foot-wide temporary easement for construction, maintenance, and repair, and then reverting to a 30-foot-wide permanent easement, for up to four (4) oil and/or gas pipelines up to sixteen inches (16") in diameter for constructing, reconstructing, operating, maintaining, installing gates, inspecting, repairing, replacing, changing the size of, re-laying, or removing pipelines together with such valves, fittings, meters, corrosion control devices, wires, cables, electronic telemetry, communications equipment, pipelines operating control devices, and other equipment and appurtenances, (referred to collectively as "above ground appurtenances"), across Allotment 706A-A in Section 4; Allotment T743A in Section 9; and Allotment 1932 in Section 8, all in T149N-R94W, McKenzie County, North Dakota; and
- WHEREAS, The ROW application, has been reviewed and recommended for approval in accordance with the MHA Nation's approved procedure for authorizing ROWs on Tribal Land.
- NOW THEREFORE BE IT RESOLVED, Subject to Targa Badlands LLC agreement to the execution of the MHA Right-of-Way Application and Terms and Conditions, as listed therein, and payment of ROW fees, the Tribal Business Council hereby approves the following ROW application, attached as Appendix A.1, and ROW consent, as follows:
  - Targa Badlands LLC the Multi-Use ROW Corridor Mandaree-Stevenson Pipelines Project, for a Right-of-Way consent to construct up to four (4) oil and gas pipelines up to sixteen inches (16") in diameter on and across the following described tracts:
    - Tract 706A-A consists of 1.472 Acres for Permanent Pipeline Right of Way and 0.721 Acres for Temporary Construction Workspace.
    - Tract T 743A consists of 0.941 Acres for Permanent Pipeline Right of Way and 0.488 Acres for Temporary Construction Workspace.
    - Tract 1932 consists of 0.177 Acres for Permanent Pipeline Right of Way and 0.075 Acres for Temporary Construction Workspace.
    - Total Disturbance for project is 3.874 Acres.

across certain tribal tracts in Allotment 706A-A in Section 4 with 75% tribal interest; Allotment T 743A in Section 9 with 100% tribal interest; and Allotment 1932 in Section 8 with 5.56% tribal interest, all in T149N-R94W, McKenzie County, North Dakota.



BE IT FURTHER RESOLVED, the ROW shall have a 20 year term.

- **BE IT FURTHER RESOLVED,** The Tribe does not consent to waive any bond, insurance, or alternative form of security.
- **BE IT FURTHER RESOLVED,** The MHA Nation Standard Terms and Conditions for Rightsof-Way are incorporated into this consent to approval of the ROW, and therefore, as provided in 25 CFR §169.107(a), the Tribal Business Council requests the Bureau of Indian Affairs to incorporate these terms and conditions into the grant of the ROW.
- **BE IT FURTHER RESOLVED,** The Tribe retains the authority to issue fines and set conditions to address and resolve ROW trespass, abandonment, non-use, and other violations, including violations of the applicable MHA Nation Standard Terms and Conditions for Rights-of-Way, and further requests the Bureau of Indian Affairs to defer to these remedies, in accordance with the intent and notice provisions, as provided in 25 CFR §169.403(a).
- **BE IT FINALLY RESOLVED,** that the Chairman is hereby authorized to execute such documents and take such further actions as are necessary to carry out the terms and intent of this Resolution.
