

# RESOLUTION OF THE GOVERNING BODY OF THE THREE AFFILIATED TRIBES OF THE FORT BERTHOLD INDIAN RESERVATION

## A Resolution Entitled: "Land Purchase - Patiently M Martinez - East Segment"

- WHEREAS, The Mandan Hidatsa and Arikara Nation (MHA Nation), also known as the Three Affiliated Tribes, having accepted the Indian Reorganization Act of June 18, 1934, the authority under said Act, and having adopted a Constitution and By-laws (the Constitution) under said Act, and
- WHEREAS, Pursuant to Article III, Section 1 of the Constitution, the Tribal Business Council is the governing body of the MHA Nation; and
- WHEREAS, The Constitution authorizes and empowers the Tribal Business Council to engage in activities on behalf of and in the interest of the welfare and benefit of the MHA Nation and of the enrolled members thereof; and
- WHEREAS, Pursuant to Article VI, Section 5(1) of the Constitution, the Tribal Business Council has the power to adopt Resolutions regulating the procedures of the Tribal Business Council, its agencies, and officials; and
- WHEREAS, The Three Affiliated Tribes has determined that it is in the best interest of the Tribe to acquire land; and the Tribe approves the purchase of land described below; and
- WHEREAS, The Tribal Business Council has considered the location of the below-described land, the potential public and economically beneficial use of the land, Tribal Self-determination; and
- WHEREAS, After such consideration the Tribal Business Council approves the purchase of said land.
- NOW, THEREFORE BE IT RESOLVED, The Three Affiliated Tribes' Tribal Business council hereby approve the purchase of the surface described below from

#### Patiently M Martinez, Tribal Member, Remainderman

For cash consideration of \$41,729.01, which is the appraised value, utilizing funds from FY2023 560 Land Purchase Account, and hereby authorizes the Chairman of the Tribal Business Council, its Secretary, the Superintendent of the Fort Berthold Agency, the Area Director, and Commissioner of the Indian Affairs to prepare all documents and do all things necessary to transfer title of the land to the United States of America, in trust for the Three Affiliated Tribes of the Fort Berthold Indian Reservation, to wit:

Allotment 301-0052A, NE¼SE¼, E½NE¼, Sec 34; W½NW¼, Section 35, Township 148 North, Range 88 West, McLean County, 5<sup>th</sup> PM of North Dakota, containing an undivided 0.0642857143 title interest, containing 12.86, acres more or less, appraised at a value of \$28,285.71.



Allotment 301-1141, Lot 4, SW¼NW¼, Section 1, Township 147 North, Range 88 West, McLean County, 5<sup>th</sup> PM of North Dakota, containing an undivided 0.0642857144 title interest, containing 5.17, acres more or less, negotiated at a value of \$13,443.30.

Total Purchase of the Land Sale is \$41,729.01

### Life Estate Title Interest of Surface Only

BE IT FINALLY RESOLVED, that the Chairman is hereby authorized to execute such documents, pursuant to legal review, and take such further actions as are necessary to carry out the terms and intent of this Resolution.
