



**RESOLUTION OF THE GOVERNING BODY OF THE  
THREE AFFILIATED TRIBES OF THE  
FORT BERTHOLD INDIAN RESERVATION**

***A Resolution Entitled: “Approval of Consent of Owners for Grant of Right of Way (ROW) for Tribal Tract T549A in the Four Bears Segment for Emergency Generator(s), a Sanitary Sewer Improvement, in the Event of Electrical Power Outages.”***

**WHEREAS,** This Nation having accepted the Indian Reorganization Act of June 18, 1934, and the authority under said Act and having adopted a Constitution and By-Laws pursuant to said Act; and

**WHEREAS,** Pursuant to Article III, Section 1 of Constitution and By Laws of the Three Affiliated Tribes, also known as the Mandan Hidatsa Arikara Nation (“Tribes” or “MHA Nation”), the Tribal Business Council is the governing body of the Tribes; and

**WHEREAS,** Article VI, Section 5 (c) of the Constitution of the Three Affiliated Tribes provides that the Tribal Business Council has the power to make expenditure from available Tribal funds for public purposes of the Three Affiliated Tribes of the Fort Berthold Indian Reservation; and

**WHEREAS,** Article VI, Section 5 (l) of the Constitution of the Three Affiliated Tribes provides that the Tribal Business Council has the power to adopt resolutions regulating the procedure of the Tribal Business Council and other Tribal agencies and Tribal Officials of the Reservation; and

**WHEREAS,** Indian Health Services and the Tribes’ Public Works Department are working towards the installation of emergency generator(s) (in re IHS Project FB22 Lift Station Generators), a sanitary sewer improvement, within the Four Bears Segment of the Fort Berthold Reservation, in the event of power outages due to natural storms throughout the year in the Four Bears Segment; and

**WHEREAS,** The Tribal Public Works Department has brought forth a United States Department of the Interior – Bureau of Indian Affairs – Consent of Owners for Grant of Right of Way for Tribal Tract T549A, trust land 100% owned by the Three Affiliated Tribes within the Four Bears Segment, which is needed for the purposes above, a public benefit; and

**WHEREAS,** The application(s) for ROW(s) described herein have been reviewed and recommended for approval in accordance with the MHA Nation’s approved procedure for authorizing ROWs on Tribal land.

**NOW, THEREFORE, BE IT RESOLVED,** that the Tribal Business Council of the Three Affiliated Tribes hereby approves the Consent of Owners for Grant of Right of

Way to MHA Nation Utilities, as presented for Tribal Tract T549A in the Four Bears Segment, for sanitary sewer improvement described above; and

**BE IT FURTHER RESOLVED**, that the term of the ROW(s) shall be perpetual (subject to termination in accordance with applicable federal regulations), and the requirements for compensation and bond are hereby waived; and

**BE IT FINALLY RESOLVED**, that the Chairman is hereby authorized to execute such documents and take such further actions as are necessary to carry out the terms and intent of this Resolution.


**CERTIFICATION**
