

RESOLUTION OF THE GOVERNING BODY OF THE THREE AFFILIATED TRIBES OF THE FORT BERTHOLD INDIAN RESERVATION

A Resolution entitled, "Approval of Negotiated Rate for Genetic Testing, such services provided by Laboratory Corporation of America Holdings, for Child Support Matters."

- WHEREAS, This Nation having accepted the Indian Reorganization Act of June 18, 1934, and the authority under said Act and having adopted a Constitution and By-laws pursuant to said Act; and
- WHEREAS, Pursuant Article III., Section 1 of the Constitution and By Laws of the Three Affiliated Tribes, also known as the Mandan, Hidatsa, and Arikara Nation (or "Tribes"), the Tribal Business Council is the governing body of the Tribes; and
- WHEREAS, The Tribal Business Council has authority to engage in activities on behalf of and for the welfare and benefit of the Tribes and of the enrolled members thereof; and
- WHEREAS, The Tribal Business Council has authority to make expenditures from available Tribal funds for public purposes of the Tribes; and
- WHEREAS, Pursuant to Article VI, Section 5 (1) of the Constitution, the Tribal Business Council has the power to adopt resolutions for Tribal Agencies; and
- WHEREAS, The TAT Division of Child Support Enforcement (or "TAT DCSE") desires to accept the rates as negotiated by the State of North Dakota for the purpose of DNA identification to provide genetic testing for the TAT DCSE's current Child Support matters; and
- **WHEREAS,** Laboratory Corporation of America Holdings is knowledgeable in the area of genetic testing services for the TAT DCSE.
- NOW, THEREFORE, BE IT RESOLVED that the Tribal Business Council of the Three Affiliated Tribes hereby approves the rates as established by the State of North Dakota on behalf of TAT DCSE with Laboratory Corporation of America Holdings to provide genetic testing; and
- **BE IT FURTHER RESOLVED** that such services shall be compensated at a rate of \$38.00 per sample submitted for analysis for the FY2024 fiscal year, ending September 30, 2024; and
- **BE IT FINALLY RESOLVED** that the Director of the TAT DCSE is authorized to inform the State of North Dakota and Laboratory Corporation of America Holdings of the Tribes' acceptance of the aforementioned rate.
