

RESOLUTION OF THE GOVERNING BODY OF THE THREE AFFILIATED TRIBES OF THE FORT BERTHOLD INDIAN RESERVATION

A Resolution entitled, "Approval of Amendment of Contract by and between the Three Affiliated Tribes for the Benefit of the West Segment, and Reindel Enterprise Inc., for Installation of Generators and General Electrician Services in the West Segment of the MHA Nation, with increase of funding to \$300,000."

- WHEREAS, The Mandan, Hidatsa, and Arikara Nation ("MHA Nation"), also known as the Three Affiliated Tribes, having accepted the Indian Reorganization Act of June 18, 1934, and the authority under said Act and having adopted a Constitution (the "Constitution") and By-Laws pursuant to said Act; and
- WHEREAS, The Constitution generally authorizes and empowers the Tribal Business Council to engage in activities on behalf of and in the interest of the welfare and benefit of the MHA Nation and of the enrolled members thereof; and
- WHEREAS, Article III, Section 1 of the Constitution provides that the Tribal Business Council is the governing body of the MHA Nation; and
- WHEREAS, Article VI, Section 5(1) of the Constitution provides that the Tribal Business Council has the power to adopt resolutions regulating the procedure of the Tribal Business Council and other Tribal agencies and Tribal officials of the Reservation; and
- WHEREAS, In about July 2023, West Segment of the MHA Nation, by and through the Three Affiliated Tribes, entered a one-year contract with Reindel Enterprise Inc. (or "Reindel") for installation of electrical generators and general electrician services. According to the West Segment Representative, Reindel has proven to be a reliable and skilled contractor for these services to the great benefit of the people of the Segment; and
- WHEREAS, The original contract with Reindel provided for maximum funding for the year term of \$150,000.00, but due to the high quality work and various activities in the Segment, there is more demand for electrician services than was originally anticipated; and
- WHEREAS, West Segment and Reindel have mutually agreed to modification of the original Contract whereby the maximum funding will be increased from \$150,000.00 to \$300,000.0, and West Segment has approved Amendment #1 to the Contract, in form as presented, providing for an increase in funding to no more than \$300,000.00 for the full term of the original Contract for Services, and seeks approval of the Three Affiliated Tribes Tribal Business Council for its execution and funding.
- **NOW, THEREFORE, BE IT RESOLVED,** that the Tribal Business Council of the Three Affiliated Tribes hereby approves the *Amendment #1 to the Contract between Three Affiliated*



Tribes for Services for West Segment and Reindel Contracting LLP, for additional electrician services needed by the Segment; and

BE IT FURTHER RESOLVED, that the Tribal Business Council of the Three Affiliated Tribes hereby approves the appropriation and expenditure of the amended total sum of no more than \$300,000.00 from TAT FY2023 and FY2024 budgets, out of the West Segment annual budget allocation, to fulfill West Segment's obligations under the aforementioned Contract and make payments due in accordance with the terms thereof; and

BE IT FINALLY RESOLVED, that the West Segment TBC Representative and the Tribal Chairman are hereby authorized to execute the aforementioned Amendment #1 to the Contract, and to take such further action as necessary to carry out the terms and intent of this Resolution.

CERTIFICATION

I, the undersigned, as Secretary of the Tribal Business Council of the Three Affiliated Tribes of the Fort Berthold Indian Reservation, hereby certify that the Tribal Business Council is composed of seven (7) members of whom five (5) constitute a quorum, 7 were present at a Regular Meeting thereof duly called, noticed, convened and held on the 19th day of October 2023, that the foregoing Resolution was duly adopted at such meeting by the affirmative vote of 7 members, 0 members opposed, 0 members abstained, 0 members not voting, and that said Resolution has not been rescinded or amended in any way.
