



**RESOLUTION OF THE GOVERNING BODY OF THE  
THREE AFFILIATED TRIBES OF THE  
FORT BERTHOLD INDIAN RESERVATION**

**A Resolution Entitled, *“Approval of GMP Amendment With Woodstone Inc. for the White Shield Boys & Girls Club/Daycare (Old Clinic) Renovation.”***

**WHEREAS,** The Mandan Hidatsa and Arikara Nation (MHA Nation), also known as the Three Affiliated Tribes, having accepted the Indian Reorganization Act of June 18, 1934, the authority under said Act, and having adopted a Constitution and By-laws (the Constitution) under said Act, and

**WHEREAS,** Pursuant to Article III, Section 1 of the Constitution, the Tribal Business Council is the governing body of the MHA Nation; and

**WHEREAS,** The Constitution authorizes and empowers the Tribal Business Council to engage in activities on behalf of and in the interest of the welfare and benefit of the MHA Nation and of the enrolled members thereof; and

**WHEREAS,** Article VI, Section 5(c) of the Constitution specifically authorizes and empowers the Tribal Business Council to administer funds within the exclusive control of the Nation and to make expenditures from available Tribal funds for public purposes for the Nation; and

**WHEREAS,** The White Shield Segment is renovating the old clinic into the White Shield Boys & Girls Club/Daycare ; and

**WHEREAS,** To complete this project the segment requires general contracting services; and

**WHEREAS,** After following the procurement guidelines, the White Shield Segment selected Woodstone Inc., to perform the services; and

**WHEREAS,** Woodstone, Inc. has developed a budget for the project and presented a guaranteed maximum price amendment (GMP Amendment) in the amount of \$6,200,000.00. and

**WHEREAS,** The White Shield Segment seeks an authorization of the GMP Amendment and a construction budget in the amount of \$6,200,000.00 for the project.

**NOW THEREFORE BE IT RESOLVED,** That the Tribal Business Council hereby authorizes execution of the GMP Amendment in the amount of \$6,200,000.00 for the aforementioned project.



**BE IT FURTHER RESOLVED,** That funding is allocated and set-aside as follows from the Tribes' Special Projects Budget:

FY 2023	\$1,400,000.00
FY 2024	\$4,500,00.00
FY 2025	\$300,000.00
Total	\$6,200,000.00

**BE IT FINALLY RESOLVED,** That the Chairman is hereby authorized to execute such documents and take such further actions as are necessary to carry out the terms and intent of this Resolution.
