

RESOLUTION OF THE GOVERNING BODY OF THE  
THREE AFFILIATED TRIBES OF THE FORT BERTHOLD RESERVATION

WHEREAS, This Corporation is an Indian Chartered Corporation as defined by the Indian Reorganization Act of June 18, 1934, as amended by the Act of June 15, 1935, and

WHEREAS, An application for the enrollment of Birdena Jean R. Fox  
Iron Necklace, U-2861, who was born on, July 30, 1950, to Esther R. Fox,  
1/4 Arikara, FB No. 1906, and Lang Iron Necklace, who signed Acknowledgment  
of Paternity, June 21, 1950. FB No. None, 1/4 Sioux  
who were residents of Billings, Montana, at the time of the birth of said  
child, and

WHEREAS, the Tribal Business Council has examined the qualifications for  
enrollment of this child and finds that,  
the parents temporary resided at Billings, Montana. The Mother has now come  
back to North Dakota and resides at Minot, North Dakota, and  
that this child is entitled to enrollment under the provisions of,  
Article II, Section 2, of the Constitution and By-Laws, and under the 1948  
Ordinances which delegates to the Tribal Business Council authority to act  
for enrollment or rejection by their vote.

NOW THEREFORE, BE IT RESOLVED, by the Tribal Business Council of the Three  
Affiliated tribes of the Fort Berthold Reservation, North Dakota, that


Birdena Jean Iron Necklace, has been reconsidered and approved by the  
Tribal Council on August 20, 1956, by vote of 7 yes and 2 no.

is hereby found eligible for membership under the Constitution and Ordinances  
of the Tribes and is hereby admitted and accepted for enrollment with the Three  
Affiliated Tribes.

CERTIFICATION

I, the undersigned, as Secretary of the Tribal Business Council of the Three Affiliated Tribes of the Fort Berthold Reservation, hereby certify that the Tribal Business Council is composed of 10 members of whom 7 constituting a quorum were present at a Special meeting thereof, duly called, noticed, convened and held on the 22nd day of October, 1956; that the foregoing resolution was duly adopted at such meeting by the affirmative vote of 7 members, 0 members opposed, 0 passed, 0 abstentions, and that said resolution has not been rescinded or amended in any way.
