- WHEREAS, the Tribal Natural Resources Committee has approved the exchange of lands between the Three Affiliated Tribes and William Bell, Sr., 301-A1757 under the terms and conditions as stated below, and now
- THEREFORE BE IT RESOLVED, that the Tribal Business Council approves the exchange of lands held in trust by the United States of America for the Three Affiliated Tribes and lands held in trust by the United States of America for William Bell, Sr., 301-A1757 under the terms and conditions as stated below and hereby authorizes the Chairman of the Tribal Business Council, its Secretary, the Superintendent of the Fort Berthold Agency, the Area Director, and the Commissioner of Indian Affairs to prepare all documents and do all things necessary to exchange lands for which title is to be transferred to the United States of America in trust for the Three Affiliated Tribes and William Bell, Sr., 301-A1757 under the terms and conditions as stated below:
- Tribal Allotment No. 528A, described as the SE4SW4, Sec. 27, excluding that portion described as: E 1320 feet from the SW4 corner of Sec. 27 to point of beginning, thence N 261 feet, thence SE 637.63 feet, thence W 755 feet to the point of beginning, containing 2.26 acres, more or less, all located in T. 152 N., R. 94 W., containing 37.74 acres, including a house, valued at \$36,117.50.
- For Allotment No. 997A, described as the S½NE¼, N½SE¼, Sec. 28, T. 150 N., R. 94 W., fifth principal meridian, North Dakota, containing 160.00 acres, more or less, valued at \$43,800.00.
