- WHEREAS, The Natural Resources Committee has approved the exchange of lands between the Three Affiliated Tribes and Colin Bearstail, under the terms and conditions stated below; and
- the exchange of lands, exclusive of minerals, held in trust by the United States of America for the Three Affiliated Tribes and lands held in trust by the United States of America for Colin Bearstail, 301-U1200, under terms and conditions as stated below and hereby authorized the Chairman of the Tribal Business Council, its Secretary, and Superintendent of the Fort Berthold Agency, the Area Director, and the Commissioner of Indian Affairs to prepare all documents and to do all things necessary to exchange lands for which title is to be transferred to the Tribe and Colin Bearstail under the terms and condition as stated NOW THEREFORE, BE IT RESOLVED, and Colin Bearstail under the terms and condition as stated below:
