- WHEREAS, Municipal, Rural and Industrial Water Project will supply much needed potable water to the communities of White Shield and Mandaree; and
- WHEREAS, The Natural Resources Committee has reviewed and determined that the Tribe will benefit more by bidding the project.
- NOW, THEREFORE BE IT RESOLVED, That the Tribal Business Council of the Three Affiliated Tribes approves the plan to solicit competitive bidding to construct the Mandaree and White Shield Water Treatment Plants and authorizes the MR&I Water Project Staff to do all things necessary to obtain a competitive price.
- BE IT FURTHER RESOLVED, That Resolution #95-180-DSB be amended to reflect the change in the water treatment portion of the above mention resolution.

- WHEREAS, The Tribe bided out the waterline from the intake to the community of White Shield and the success full bidder is O'Lander Construction, and;
- WHEREAS, The Water Treatment Plants contracts shall be awarded to LCM Corporation.
- NOW, THEREFORE BE IT RESOLVED, That the Tribal Business Council of the Three Affiliated Tribes hereby accepts the bid as follows:
  - 1. O'Lander Construction for the White Shield Pipe line.
    - Bid schedule I Alternate I not to exceed \$1,104,223.00
    - The minimum price of \$827,492.00 (If bedding gravel is not required)
  - 2. LCM Construction will construct the Treatment Plants as Follows:
    - Mandaree Treatment Plant not to exceed \$ 469,721.00
    - White Shield Treatment Plant not to exceed \$1,200,513.00

BE IT FURTHER RESOLVED, That Tribal resolution 95-108 DSB be rescinded in its entirety.
