Getting on the Agenda

1. Committee Level Approval

To present before the Three Affiliated Tribes Tribal Business Council (TBC) you must first get on the Agenda. All TBC Agenda items are vetted by committee to determine if your item requires full TBC approval or can be resolved at the committee level. If full TBC approval is required your item would then be forwarded to the TBC Agenda with a recommendation from one of the eight Committees below. You may submit the Agenda Request Form to the appropriate Committee/Offices of the chairperson to request addition to that respective committee agenda:

2. Forwarded to the Tribal Business Council Agenda

During the Committee Meeting your item will be addressed, or a vote will be taken as to forward your item to the next Regular or Special TBC Meeting agenda. Regular TBC meetings occur the second Thursday of every month. Occasionally meeting dates/times change so regularly check the Records Office Calendar. 3. Exceptions to the Committee Rule:

- o If you are an invited guest or Elder (+60 years of age) and not currently an employee of the MHA Nation, you can request to be on the agenda by contacting the Councilman of the segment you currently reside, or the Chairman's Office for off-reservation members.
- Every Councilman also has the option of adding 2 agenda items under the New Business Section of the agenda (Add On). You will need to contact your respective Council representative to ask to be an add-on, and they must be emergencies.
