



**RESOLUTION OF THE GOVERNING BODY OF THE
THREE AFFILIATED TRIBES OF THE
FORT BERTHOLD INDIAN RESERVATION**

A Resolution Entitled, “*Exclusion of Dustin Shot With Two Arrows from the Fort Berthold Indian Reservation.*”

- WHEREAS,** The Mandan Hidatsa and Arikara Nation (MHA Nation), also known as the Three Affiliated Tribes, having accepted the Indian Reorganization Act of June 18, 1934, the authority under said Act, and having adopted a Constitution and By-laws (the Constitution) under said Act, and
- WHEREAS,** Pursuant to Article III, Section 1 of the Constitution, the Tribal Business Council is the governing body of the MHA Nation; and
- WHEREAS,** The Constitution authorizes and empowers the Tribal Business Council to engage in activities on behalf of and in the interest of the welfare and benefit of the MHA Nation and of the enrolled members thereof; and
- WHEREAS,** Article VI, Section 5(c) of the Constitution specifically authorizes and empowers the Tribal Business Council to administer funds within the exclusive control of the Nation and to make expenditures from available Tribal funds for public purposes for the Nation; and
- WHEREAS,** The provisions for Civil Exclusion are at Title II, Chapter 5 of the Tribal Code; and
- WHEREAS,** Exclusion includes the removal of the person and any of their property from the Fort Berthold Indian Reservation at the person's expense and prevention of the reentry of the person onto the Reservation for such period of time as set forth by Tribal law; and
- WHEREAS,** Under Section 2-5-8.7 of Title II of the Tribal Code, the Tribal Prosecutor may request an Emergency Writ of Exclusion when the continued presence of a person will result in immediate danger to the health, safety, welfare, life, or property of the Tribe or any enrolled tribal member and where delay is likely to result in irreparable damage; and
- WHEREAS,** The continued presence of Dustin Shot With Two Arrows represents an immediate danger and any delay in his exclusion will result in irreparable damage.



NOW, THEREFORE, BE IT RESOLVED, that the Tribal Business Council directs the Tribal Prosecutor to file for an Emergency Writ of Exclusion against Dustin Shot With Two Arrows as provided for in Section 2-5-8.7 of Title II of the Tribal Code; and

BE IT FURTHER RESOLVED, that the Chairman of the Tribal Business Council is hereby authorized to execute such documents and to take such further actions as are necessary to carry out the terms and intent of this Resolution.


CERTIFICATION

I, the undersigned, as Secretary of the Tribal Business Council of the Three Affiliated Tribes of the Fort Berthold Indian Reservation, hereby certify that the Tribal Business Council is composed of seven (7) members of whom five (5) constitute a quorum, 7 were present at a Regular Meeting thereof duly called, noticed, convened and held on the 8th day of April, 2026, that the foregoing Resolution was duly adopted at such meeting by the affirmative vote of 7 members, 0 members opposed, 0 members abstained, 0 members not voting, and that said Resolution has not been rescinded or amended in any way.
