PROCEDURE TO CONTEST THE SEPTEMBER 22, 2026 PRIMARY

Pursuant to Chapter IX, Section 1 A, of the Election Ordinance of the Three Affiliated Tribes, a defeated candidate or ten (10) qualified Tribal voters who desire to contest an election after the results thereof have been formally certified, shall file with the Tribal Election Board a duly verified written complaint setting forth a concise statement of the facts upon which the contest is based, together with a nonrefundable filing fee in the amount of Five hundred Dollars (\$500.00), within a period of three (3) days from the date on which the election results were certified, exclusive of Sundays and holidays.
